

 2. Letter of LSO Acknowledgment dated June 28, 2012, signed by Keith Carsten, Assistant Director.
11. Authorized nonionizing radiation users for this registration will be approved by Keith Carsten, Assistant Director. A current list of the approved operators will be maintained at the facility.
